Business Networking with the Ambassador Jean-François PACTET.

A meeting was held between His Excellency Jean-François Pactet, Ambassador for France, and the Sri Lanka France Business Council (SLFBC) of the Ceylon Chamber of Commerce. The purpose of the meeting was to discuss France's support for Sri Lanka in its endeavors to restructure its debt and stimulate economic recovery. The meeting was attended by Ambassador Designate of Sri Lanka to France, Mrs. Manisha Gunasekera, members of the French business community, and Sri Lankan partners of French companies.

Spaeking on France's Support for Sri Lanka's Economic Recovery, Ambassador Pactet emphasized France's commitment to assisting Sri Lanka in its economic recovery efforts. He highlighted the significant contributions France has made and continues to make in various sectors including water, energy, urban development, agriculture, and renewable energy. The Ambassador acknowledged the potential for French companies to contribute to the Sri Lankan economy in sectors such as logistics, digital technologies, and health.

Mr. Ashiq Lafir, President of the SLFBC, provided an overview of the council's mission and initiatives aimed at promoting bilateral trade and investment between France and Sri Lanka. He briefed the Ambassador on the ongoing efforts to strengthen business linkages between the two countries.

During the meeting, a roundtable discussion took place to explore the potential for further developing business linkages between France and Sri Lanka. The participants also addressed the challenges associated with bilateral trade and investment within the current economic context. Furthermore, the role of the private sector in overcoming these challenges was discussed.



Wine Evening 2023

The Sri Lanka - France business council and the European Chamber of Commerce of Sri Lanka (ECCSL) co-organized the "wine evening 2023" on Thursday February 16, 2023 at Galle face hotel, with the support of the economic section of the French embassy in sri lanka.

French Ambassador Jean-François Pactet was the guest of honor at the event and recalled the intensity of Franco-Sri Lankan cooperation in strategic sectors such as water, energy, agriculture and environmental protection, before calling for the maintenance and intensification of this cooperation in the years to come.

A ceremony was held during which SLFBC President Ashiq Lafir and ECCSL President Hatem Rajabdeen signed a Memorandum of Understanding towards enhanced cooperation and synergies between the two organizations.

The event, which was attended by Sri Lankan officials such as the Governor of the Central Bank and the Secretary of State for Foreign Affairs, aimed primarily to promote French culture in Sri Lanka and to encourage exchanges between more than 200 institutional and economic actors gathered in the Jubilee Ballroom.


The participants had the opportunity to taste French wines, selected in order to promote the know-how of French winegrowers.



INDEPENDENT AUDITOR'S REPORT

TO THE EXECUTIVE COMMITTEE OF SRI LANKA - FRANCE BUSINESS COUNCIL

Opinion

We have audited the statement of receipts and payments ("the Statement") of Sri Lanka – France Business Council ("the Council"), for the year ended 31 March 2023 and notes to the statement of receipts and payments.

In our opinion, the accompanying statement presents fairly, in all material respects, the receipts and payments of the Council for the year ended 31 March 2023 in accordance with the receipts and payments basis of accounting described in Note 2.



SUMMARY OF EXTERNAL TRADE WITH FRANCE 2018 – 2022





Main Items Exported from Sri Lanka to France – 2022

Apparel & Clothing products dominate exports revenue of 33% from France with rubber products earning 13% and Fish & crustaceans earning 12% of the revenue. Nuclear reactors, boilers, machinery and mechanical appliances, account for 3% while other items bring in a revenue of 11%.



Main Items imported to Sri Lanka from France – 2022

Pharmaceutical Products account to the largest share of imports being 17% followed by Neuclear reactors, boilers, machinery and mechanical appliances, parts thereof and Optical, photographic, cinematographic, measuring, checking with 14% & 11% shares respectively. Sri Lanka also imports Beverages, Spirits, Vinegar from France which is 5% of the total imports.





Balance of Trade - Sri Lanka and France

Exports from Sri Lanka has seen an increase during 2018 to 2022, from USD 197 million to USD 256million while Imports record a fall during the same period from USD 279 million to USD 110 million. Both exports and imports has experienced an increase compared to the last financial year.

Over the past 5 years Trade has experienced fluctuations in both export revenue and imports during the period of 2018 – 2022. The percentage of increase of the exports than the imports has resulted a trade surplus of 145.66 million in 2022.


TOURISM

The tourism industry between France and Sri Lanka has witnessed significant growth in visitor arrivals over the last five years. Both countries have seen a steady increase in the number of tourists traveling between them, highlighting the growing interest and connectivity between the two nations.


French visitors to Sri Lanka: Sri Lanka has become an increasingly popular destination among French travelers. The island nation's natural beauty, cultural heritage, and warm hospitality have attracted a growing number of tourists from France. The ease of obtaining travel visas and improved air connectivity have further contributed to this upward trend.

Tourism revenue: The increase in tourism between France and Sri Lanka has contributed positively to the economies of both countries. Tourism revenue from French visitors has had a significant impact on the local economies of popular destinations in Sri Lanka, providing employment opportunities and boosting local businesses. Similarly, the spending by Sri Lankan tourists in France has contributed to the French economy, particularly in the hospitality, retail, and transportation sectors.

Challenges: While the pandemic has posed temporary setbacks, the long-term prospects for tourism between France and Sri Lanka remain promising. It is crucial for stakeholders in both countries to continue working together to revive and strengthen this important sector for the benefit of both nations.



It is observed that Frances' share to total tourist influx to the country is recorded 4.9% which is a 1.5% increase compared to the last year. France holds the 5th position amongst the top 10 markets sourcing International Tourists.
